# ORDER NO. 0 4 4 3 0 / MINFOPRA OF 0 3 0CT 2017

To announce a direct competitive examination for the recruitment of 100 (one hundred) Ecoguards into the corps of Forestry civil servants, for the 2017 session.

#### THE MINISTER OF THE PUBLIC SERVICE AND ADMINISTRATIVE REFORM,

Mindful of the Constitution;

Mindful of decree No. 75/785 of 18 December 1975 on the Special Rules and Regulations of the corps of Rural Production civil servants;

Mindful of decree No. 94/199 of 7 October 1994 on the General Rules and Regulations of the Public Service, as amended and supplemented by decree No. 2000/287 of 12 October 2000;

Mindful of decree No. 2011/408 of 9 December 2011 to organize the Government;

Mindful of decree No. 2011/410 of 9 December 2011 to form the Government;

Mindful of decree No. 2015/434 of 2 October 2015 to reshuffle the Government;

- Mindful of decree No. 2012/537 of 19 November 2012 to organize the Ministry of the Public Service and administrative Reform;
- Mindful of decree No. 2000/696/PM of 13 September 2000 to fix the General System of Government Competitive Examinations,

# HEREBY ORDERS AS FOLLOWS:

<u>Article 1</u>.- a) A direct competitive examination to recruit Ecoguards into the corps of Forestry civil servants have been announced. The number of available places for the various categories is distributed as follows:

- 15 (fifteen) Forestry Engineers of the second grade of the 'A' category of the Public Service;
- 10 (ten) Assistant Forestry Engineers of the first grade of the 'A' category of the Public Service;
- 15 (fifteen) Senior Forestry Technicians of the second grade of the 'B' category of the Public Service;
- 20 (twenty) Forestry Technicians of the first grade of the 'B' category of the Public Service;
- 20 (twenty) Assistant Forestry Technicians of the "C" category of the Public Service;
- 20 (twenty) Forestry Technical Assistant of the "D" category of the Public Service.

b) The said examination shall take place on the 4 and 5 November 2017 in Yaounde, the only examination centre.

#### Article 2.- REQUIREMENTS

This examination shall be open to all Cameroonians who fulfil the requirements for admission to government employment and conditions laid down by the General Rules and Regulations of the Public Service. **VISA**

#### Article 3.- FILE COMPOSITION

Candidates' complete application files shall be submitted, against a receipt, at the Ministry of the Public Service and Administrative Reform, Department of State Human Resources Development, Direct and Scholarship Competitive Examinations Service (4<sup>th</sup> floor, Rooms **405 and 409**) or in all Regional Delegations of the Public Service, Recruitment and Training Service, no later than **Friday 20 October 2017**. The files shall comprise the following documents:

- a registration form bearing a CFA 1000 francs fiscal stamp. The forms can be obtained from the Ministry of the Public Service and Administrative Reform or at all Regional Delegations of the Public Service or downloaded at the website <u>http://www.minfopra.gov.cm</u>;
- 2. a certified true copy of birth certificate signed by a competent civil authority;
- 3. a certificate of non-conviction;
- 4. a certified true copy of the required certificate signed by a competent civil authority;
- 5. an attestation of presentation of original of the required certificate signed by a competent civil authority;
- 6. a medical certificate issued by a public sector Medical Officer;
- 7. a receipt attesting payment of a registration fee of CFA 15 000 (fifteen thousand) francs issued by either the Service Head for Scholarships and Direct Competitive Examinations or the Head of the Recruitment and Training Service at the Regional Delegations of the Ministry of the Public Service and Administrative Reform;
- 8. 2 (two) passport-size photographs;
- 9. an envelope bearing a CFA 500 francs stamp and the candidate's address.

<u>N.B</u>.:

- State employee candidates governed by the Labour Code who meet the conditions set out in Article 2 shall provide a copy of their contract or decision of employment.
- All incomplete or late files or files containing documents signed at a Police station shall be rejected.
- All documents should be certified by a competent civil, municipal or legal authorities and not more than 3 (three) months old at the time of submission of file.

## Article 4.- SYLLABUS AND EXAMINATION TIMETABLE

- 1. The syllabus for this examination shall be that of the training institutions that have issued the required certificate for application.
- 2. The written part of the examination which shall take place in the Yaounde centre only shall be scheduled as follows:
