## HEREBY ORDERS AS FOLLOWS:

TRE Article 1.- a) A direct competitive examination to recruit 10 (ten) Surveys Fechnicians of the first grade of the "B" category of the Public Service.

b) The written part of this examination shall take place on the 21 and 22 September 2019 in Yaounde, the only examination centre.

#### Article 2.- REQUIREMENTS.

This examination shall be open to all Cameroonians who fulfil the following conditions:

- a) fulfil all the requirements for admission to a public service employment and conditions laid down by the General Rules and Regulations of the Public Service:
- b) be physically fit to assume the duties of Surveyor;
- c) be at least 17 years of age and 34 years at most as at 1st January 2019 the born between 01/01/1985 and 01/01/2002);
- d) be holder of a Diploma of Topographical Surveys Technician issued by a national institution of training or by a recognized foreign or international institution of training featuring on the list approved by Prime Ministerial order.

#### Article 3.- FILE COMPOSITION.

Candidates' complete application files shall be submitted, against a receipt, at the Ministry of the Public Service and Administrative Reform, Department of State Human Resources Development, Direct and Scholarship Competitive Examinations Service (4th floor, Rooms 405 and 409) or in all Regional Delegations of the Public Service, Recruitment and Training Service, latest Friday 6 September 2019. The files shall comprise the following documents:

  - State employee candidates governed by the Labour Code who meet the conditions set out in Article 2 shall provide a copy of their contract or decision of employment.

  - All documents should be certified by competent civil, municipal or legal authorities and not more than 3 (three) months old at the time of submission of file.
