To announce a direct competitive examination for the recruitment of 60 (sixty) personnel into the corps of Rural Production (Rural Engineering) civil servants, for the 2019 session.

Competitive Examinations,

HEREBY ORDERS AS FOLLOWS:

Article 1.- a) A direct competitive examination to recruit personnel into the corps of Rural Production (Rural Engineering) civil servants have been announced. The number of available places for the various categories is distributed as follows:

b) The written part of this examination shall take place on the 21 and 22 September 2019 in Yaounde, the only examination centre.

Article 2.- REQUIREMENTS.

1. General requirements:

This examination shall be opened to all Cameroonians who fulfil the fullowing conditions

- a) fulfil all the requirements for admission to a public service employment and conditions laid down by the General Rules and Regulations of the Public Service,
- b) be physically apt to assume the duties of Rural Engineering;

- c) Be at least 17 and at most 29 years of age as at 1st January 2019 (be born between 01/01/1990 and 01/01/2002) for candidates for the "C" category;
- d) Be at least 17 and at most 34 years of age as at 1st January 2019 (be born between 01/01/1985 and 01/01/2002) for candidates for the "A" and "B" categories.
- 2. Specific requirements

a – For candidates for admission into the corps of Rural Engineers, be holder of a Diploma of Rural Engineer or a Diploma of Rural Engineer in Agricultural Machinery or a recognized equivalent diploma issued by a government national institution of training or by a recognized foreign or international institution of training approved by Prime Minister's order.

b- For candidates for admission into the corps of Assistant Rural Engineers, be holder of a Diploma of Assistant Rural Engineer or a Diploma of Assistant Rural Engineer in Agricultural Machinery or a recognized equivalent diploma issued by a government national institution of training or by a recognized foreign or international institution of training approved by Prime Minister's order.

c- For candidates for admission into the corps of Senior Rural Technicians, be hower of a Diploma of Senior Rural Technician or a recognized equivalent diploma issued by a government national institution of training or by a recognized foreign or international institution of training approved by Prime Minister's order.

d- For candidates for admission into the corps of Rural Technicians, Diploma of Rural Technician or a recognized equivalent diploma issued by a prime ment national institution of training or by a recognized foreign or international institution of training approved by Prime Minister's order.

approved by Prime Minister's order. e- For candidates for admission into the corps of Assistant Rural Technicians, Be hower of a Diploma of Assistant Rural Technician or a recognized equivalent diplomate issues by a government national institution of training or by a recognized foreign or international institution of training approved by Prime Minister's order.

Article 3.- FILE COMPOSITION.

Candidates' complete application files shall be submitted, against a receipt, at the Ministry of the Public Service and Administrative Reform, Department of State Human Resources Development, Service for Direct Competitive Examinations and Scholarship (4th floor, Rooms 405 and 409) or in all Regional Delegations of the Public Service, latest Friday 6 September 2019. The files shall comprise the following documents:

1. A registration form bearing a CFA 1000 francs fiscal stamp in which the candidate specify his or her option. The forms can be obtained from the Ministry of the Public Service and Administrative Reform or at all Regional Delegations of the Public Service or downloaded at the following website address: <u>http://www.minfopra.gov.cm</u>

2. A certified true copy of birth certificate signed by a competent civil authority.

3. A certificate of non-conviction;

4. A certified true copy of the required certificate signed by a competent civil authority;

5. An attestation of presentation of original of the required certificate signed by a competent civil authority;

6. A medical certificate issued by a public sector medical officer;

7. A receipt attesting payment of a registration fee of CFA 15 000 francs (fifteen thousand) issued by an EXPRESS UNION official at the place of submission of the application files; 8. 2 (two) passport-size photographs;

9. A CFA 500 francs stamped envelope bearing the candidate's address.

<u>N.B</u>:

- In the absence of applications in the option or quorum not met, the number of places reserved or remaining shall be redeployed to the other option.
- State employee candidates governed by the Labour Code who meet the conditions set out in Article 2 shall provide a copy of their contract or decision of employment.
- All incomplete or late files or files containing documents signed by the police shall be rejected.
- All documents should be certified by a competent civil, municipal or legal authorities and not more than 3 (three) months old.

Article 4.- SYLLABUS AND EXAMINATION TIMETABLE

- 1. The syllabus for this competitive examination shall be those of the training institutions that have issued the certificate required for application.
- 2. The written part for candidates for recruitment as Rural Engineers, Assistant Rural Engineers, Senior Rural Technicians and Rural Technicians shall be scheduled as follows:
